

Snapshot: UK Public Health Register Re-accreditation decision



ACTIVITIES & ACTIONS SHOWING HOW UKPHR IS MEETING THE STANDARDS FOR ACCREDITED REGISTERS

▶Commitment to protecting the public/promoting confidence

UKPHR estimates that with the GMC and the GDC, all UK based Public Health Specialists are registered. UKPHR estimates that only about 5% of the practitioner workforce is registered, despite practitioner registration schemes being available throughout the UK. UKPHR is taking action to promote the register and increase the levels of registration within this group.

▶Managing risk

UKPHR actively considered the Covid-19 national emergency, it has posted a statement on its website. It will be flexible with timescales for revalidations and professional appraisals and has worked with Public Health England to ensure a joint approach to this flexibility. UKPHR has created a temporary register for returning professionals.

DGovernance

UKPHR will be updating its terms of reference for its Board Directors so that it has a third of Directors retiring annually and will be developing written procedures to introduce a maximum term of office for its Directors. UKPHR's Audit and Risk Committee regularly reviews the risk register and business plan and has been overseeing its Covid-19 response.

• Handling complaints and concerns

UKPHR received one complaint which was assessed by the Registrar and not taken forward. UKPHR developed its vexatious complaints policy.

UKPHR has developed a new website which provides information to the public, employers and registrants. UKPHR publishes its register, its complaints procedures, and its standards for registrants.

UKPHR has lay Board Directors who can provide the public perspective to decisions that are made. UKPHR also holds regular Consultative Forums to which a wide range of stakeholders are invited to provide their views.

UKPHR is working on the development of a new route to the register for those who successfully complete their apprenticeship so ensuring that more of the public health workforce will be registered.

UKPHR has developed revalidation procedures for its registrants. Registrants will be required to do this every five years. This has been put into place for Public health Specialists and UKPHR is working on the process for Public health Practitioners who currently have to re-register every five years. These processes help ensure that UKPHR's registrants are maintaining the required standards for registration.

Recommendations

RECOMMENDATIONS:

- 1 The UKPHR should consider adding working with children and vulnerable groups as a separate risk to its risk register. (Standard 3)
- The UKPHR to consider developing guidance for its registrants and for its staff/Board about handling safeguarding issues. (Standard 3)
- **3** UKPHR should consider adding a statement to its website to ensure that it is clear that people can request Board meeting minutes from UKPHR. (Standard 5)
- **4** UKPHR should consider improving the provision of information about the knowledge base or its development to the public. (Standard 6)
- **6** UKPHR should consider developing guidance for its registrants about whistleblowing and the professional Duty of Candour. (Standard 8)
